

- Our networking with the WPA and other professional organisations are getting strengthened day by day. Presence of the WPA and its executive committee members at our meetings add further support to these relations.
- We have started some joint with the WPA in the areas of teaching and training in psychiatry. Our secretary for educations (Prasad Rao) and Roger Ng (WPA secretary for education) are currently involved in conducting a survey and formulating some training modules with his counterpart at WPA.
- AFPA's initiatives and continuous support to the research of antipsychotic drug (REAP) studies is opening new avenues for collaborative research among Asian countries. Well done Prof. Shinfuku for your leadership in this area! Many of our valued professional colleagues have been participating in REAP studies and getting their work published in peer reviewed journals.
- Our work for supporting young psychiatrists is gaining more popularity and organisation of special sessions at our meetings is taken as a step forward in this important area of research, teaching, and training.
- Increasing number of AFPA co-sponsored meetings and conferences have also been a salient feature of our activities.

We are grateful to Philippines Psychiatric Association for organising an international congress in February 2018 as well as Indian Psychiatric Society and Indian Association of Private Psychiatrists for an international seminar in November 2018. Those meetings were well-attended and well-organised, AFPA W

and attracted many delegates from different Asian countries. We had a noticeable presence of young psychiatrists at those congresses. Special training sessions for the young psychiatrists were a prominent feature of those meetings. We also received a lot of support for conducting and supporting special sessions and workshops from our member societies, and many other organisations including World Association for Psychosocial Rehabilitation, Royal Australian and New Zealand College of Psychiatrists, Royal College of Psychiatrists of the United Kingdom, non-governmental organisations working in the field of mental health.

- Our consultation and collaboration with the Pacific Rim College of Psychiatrists (PRCP) is going on along with our plans for having a joint journal. We achieved an outstanding success in this regard by launching this initiative with the PRCP at Philippines Congress. We are currently discussing further steps with the PRCP and Wiley (the publishers of the journal)for linking our members for free access to this journal. Prof. Shinfuku will contact you with further details.
- After the success of our seminar on postgraduate Education at Abu Dhabi in 2018, Mohan Isaac was successful in getting a scientific publication from this seminar. We are grateful to Norman Sartorius for his guidance for this project.
- We have almost finalised arrangements for our 7th World Congress of the AFPA (WCAP 2019 at Sydney). Salient features of the WCAP 2019 are participation of renowned speakers from across the region, pre-congress workshops (on "Professionalism, Health and Well-being for the Medical Practitioner," and "Mindfulness-based Therapy and Counselling" developed from Thailand, and teaching programmes for young psychiatrists), plenary sessions by eminent speakers (including Henry Brodaty (Australia), Eric Chen (Hong Kong), Helen Hermann (Australia), Shigenobu Kanba (Japan), Dan Lubman (Australia) and Norman Sartorius (Switzerland). Concurrent sessions in different streams include child and adolescent psychiatry, service issues and responses to disaster, clinical psychiatry, ageing and physical and mental health, and women's mental health.

In addition, there will also be three AFPA presidential symposia (Training and Workforce in Psychiatry, Mental Health Promotion and Suicide Prevention). We also have a plan to hold special strategy meetings with the AFPA board on mental health legislation, rights of persons with Disabilities (discussions about UN CRPD guidelines) and developing

partnership with other stake holders in mental health like non psychiatrist professionals, patients and family groups. These breakfast sessions will help our member societies for developing strategies and policies in these important areas. You will also find a feature on the 7th WCAP in Sidney, 21-24 February, 2019 in this issue of the Bulletin. I am pleased that our member society (RANZCP) has played an important rôle in organising this Congress.

In addition, there will also be three AFPA Presidential symposiums:


- "Training and Workforce in Psychiatry" (22 February, Friday)

Malcolm J. Hopwood to Become AFPA President



Malcolm John Hopwood will become the president of the Asian Federation of Asian Associations, 2019-2021, to succeed Afzal Javed (Pakistan) at the close of the 7th World Congress of Asian Psychiatry at Sidney, Australia, 14-17 February, 2018.

Hopwood was graduated from the University of Melbourne, Australia in 1986 with a Bachelor of Medicine and Bachelor of Surgery (MBBS), and gained his fellowship of the Royal Australian and New Zealand College of Psychiatrists in 1994, along with a Master of Psychological Medicine from Monash University. In 1997, he also completed a Doctor of Medicine (MD) from the University of Melbourne.

After working in the public health-care system for many years, Professor Hopwood now holds the positions of Ramsay Health Care Professor of Psychiatry at the University of Melbourne and Clinical Director, Professorial Psychiatry Unit at the Albert Road Clinic.

Hopwood's research areas of interest include clinical aspects of mood and anxiety disorders, psychopharmacology, and psychiatric aspects of neurological disability including acquired brain injury.

Hopwood has contributed to many committees, including the Victorian Department of Human Services Bushfire Psychosocial Recovery Evaluation Advisory Committee, the Victorian Psychosurgery Review Board, the Commonwealth Department of Veterans' Affairs National Clinical Advisory Group ,the Multidisciplinary Panel for the Revision of the Australian NHMRC Guidelines for Acute Stress Disorder and Posttraumatic Stress Disorder. He also chaired the recent Commonwealth Department of Health Medicare review Committee for Psychiatry, which reviewed all of the national government insurer's funding of psychiatric services. He is also a member and previous chairman of the Board of the Summer Foundation, which provides advocacy, support, and sector development for young people with acquired brain injuries living in nursing homes, as well as a Board member of Phoenix, a national organisation involved in the response to trauma-related mental health.

Within the RANZCP, Hopwood has held many rôles, including as Victorian Branch Chair (2009 -2013). He was a member of the binational General Council (2007 - 2009), and a Member of the Board of Research for 10 years. He is also a member of the Faculty of Psychiatry of Old Age and the Section of Neuropsychiatry.

Hopwood was elected to the RANZCP's inaugural Board as President-elect in 2013 and served as President (2015 - 2017). He completed his two-year term presidency at the close of RANZCP annual congress 30 April - 4 May, 2017 in Adelaide. As part of his presidency, Hopwood strongly pursued the RANZCPs strategic aim of developing further relationships across Asia.

Since 2013, Hopwood has been actively participating in AFPA as a delegate, a speaker, and as a faculty member for training workshops in teaching young psychiatrists at various AFPA congresses. In 2017, he was elected as president-elect of the AFPA at the executive council meeting at 6th WCAP in Abu Dhabi, United Arab Emirates, 23-26 March, 2017. FROM PRESIDENTS OF AFPA NATIONAL PSYCHIATRIC SOCIETIES

The Report of the TSOP 57th Annual Meeting at Taichung, 3 - 4 November, 2018

The Taiwanese Society of Psychiatry held a successful 57th annual meeting at Chung Shan Medical University, Taichung, Taiwan, 3-4 November, 2018. This annual meeting had sessions of 25 panel discussions, 8 workshops, 5 educational speeches, and 169 poster presentations.

The theme of the annual meeting theme was "e-Health Care and Psychiatry." To elaborate the meeting theme, the programme committee carefully arranged three sessions consisting of three keynoters to elaborate the meeting theme:

- "Artificial Intellegence" in Health Care," by Yu-Chuan Li (College of Medical Science and Technology, Taipei Medical University)
- "AI for Behaviour Computing: Case Studies in Healthcare Applications," by Chi-Chun Lee (Department of Electrical Engineering, National Tsing Hua University, Hsinchu, Taiwan)
- "Recent Advances in Electroencephalography-based Major Depressive Disorder Detection," by Yi-Hung Liu (Department of Mechanical Engineering, National Taipei University of Technology, Taipei, Taiwan

To echo the main theme for e-health care, we invited several tech companies to exhibit various advanced therapy and health monitoring devices including transcranial magnetic stimulation, heart rate variability, bio-feedback, neuro-feedback, as well as system for health data analysis and management.

Regarding the important course of ethics and medical regulations, Po-Chang Lee, the director-general, National Health Insurance Administration gave a talk of "Rational Use of Medical Resources: Improving Medical Ecology." Besides, issues of long-term care, mental health act, mental health in army, training programs, medical practice in psychiatric clinic, and atypical career guidance for psychiatrist were scheduled in many symposia throughout the annual meeting. As usual, continuing necessity exists to enhance understanding and learning on essential topics in geriatric psychiatry, child and adolescent psychiatry, psychosomatic medicine, psychotherapy, precision medicine, changes in diagnostic system, epidemiology in psychiatry, big data research and analysis, and medical education in psychiatry, there were many abundant and practical special lectures and workshops at the meeting. In addition, an educational course "Quit Smoking," an important topic covering both physical and mental health, was co-organised by Taiwanese Association of Family Medicine.

At the annual meeting, the Academic Achievement Award was issued to Ton-Ping Su to recognise his lifetime eminent accomplishment. Su also gave a speech to recount his research effort at the annual meeting.

This year, we had more than 1,300 participants, taking part at the 57th annual meeting 2018. All experts, attendees at the conference, believed to gain a lot of profits from the knowledge obtained from the annual meeting. (The authors declare no conflicts of interest in writing this report.)

The 2018 TSSR Annual Symposium of TSSR Focusing on Imaging Studies in Schizophrenia

The annual symposium of Taiwanese Society for Schizophrenia Research (TSSR) 2018 was co-organised with the Consortium for Mental Disorders (CMD), Taiwan and Mental Health Foundation (MHF), Taiwan. The conference took place at the Sweetme Hotspring Resort, Beitou, Taipei, Taiwan, 25-26 August, 2018.

The theme of the conference was "Neuroimaging Research in Schizophrenia," focusing on neuroimaging and relevant postmortem brain research in schizophrenia by international and domestic speakers. Recent advances in neuroimaging research provide possible biological mechanisms in complex mental disorders including schizophrenia, but in Taiwan, the research in this field is at the relatively early stage. This conference was aimed at promoting the research in this field and providing a platform for relevant researchers to communicate and collaborate.

Yasuto Kunii from Fukushima Medical University, Japan presented genetic neuropathology in schizophrenia using post-mortem brain and showed how their team has organised the brain bank in Japan. Niall Duncan from Taipei Medical University, Taiwan presented subcortical contributions to cortical dynamics in schizophrenia using fMRI from a basic science perspective to explore the possible mechanism of clinical psychopathology in schizophrenia. Tzung-Jeng Hwang from National Taiwan University, Taiwan presented tractography-based imaging markers for schizophrenia and its relationship with clinical course and

treatment response.

The TSSR has a long history of collaboration with Japanese Society of Schizophrenia Research and other Asian research society related to schizophrenia. TSSR has initiated the travel award programme since 2017 to support young researchers to attend international conferences relevant to schizophrenia research.

At this meeting, we also invited the 2018 TSSR travel award winner, Hong-Hsiang Liu from National Taiwan University and another young researcher in the field, Hsiao-Lun Ku from Taipei Medical University to present their recent works. As in the past, the TSSR held a "The Positive and Negative Syndrome Scale (PANSS)" training workshop, lectured by Chih-Min Liu from National Taiwan University, to promote the clinical and research skills of young psychiatrists and clinical researchers.

The conference has successfully brought together the academic and clinical researchers in schizophrenia research, and provided excellent chances for young researchers to build up their early experience presenting their works in domestic and international conferences in our neighbouring nations in Asia. In April 2019, we plan to hold a symposium in the first conference of Research and Education Center of Bridging Asian Mental Health and Psychiatry (REBAMP), Tainan, Taiwan to further promote the research connection with Asian countries and to encourage young psychiatrists and researchers to participate and to contribute. A Report of the Asia-Pacific Regional Congress of the WFSBP, 7-9 September, 2018

Asia Pacific Regional Congress of World Federation of Society of Biological Psychiatry (WFSBP) was held at Kobe Chamber of Commerce and Industry, 7-9 September, 2018, under the theme of "Science of Mind" organized by Ichiro Sora (Kobe University) as the Congress chair, and by me as chair of scientific programme.

The scientific programme covered six plenary lectures:

- "Dissecting our Mind: Based on Evolutionary Conservation" by Hiroshi Okamoto RIKEN, Japan
- "Do Atypical Antipsychotic Drugs Improve Positive, Negative, and Cognitive Symptoms by Modifying Synaptic Abnormalities and Restoring Synaptic Function?" by Herbert Meltzer, Northwestern University, USA
- "Clozapine with Schizophrenia: A Personal Perspective from Basic Laboratory Findings to Clinical Observation" by Yong Sik Kim, Dongguk University, Korea
- "Stem Cell-based Therapy for Parkinson's Disease" by Jun Takahashi, Kyoto University, Japan
- "Cellular, Circuit, and Behavioral Homeostasis in Treatment-resistant Depression and Rapid-acting Antidepressants" by Carlos Zarate (National Institute of Mental Health, USA
- "Recovery for Psychoses: A Known Concept with a Potential for New Treatment Options" by Peter Falkai, Munich University, Germany

Two special lectures were "Staging Disease, Optimizing Treatment" by Yu Xin (Peking University, China), and "Anticraving Drugs for Alcohol Use Disorder: A Clinical Review" by Winston W. Shen (Taipei Medical University, Taiwan). The programme was rich with more than 20 symposia, 3 luncheon seminars, and 150 poster presentations.

The Congress was organised in conjunction with the Joint Meeting of the 40th Annual Meeting of Japanese Society of Biological Psychiatry (6-8 September 2018; chair, Shigenobu Kanba); and the 61th Annual Meeting of Japanese Society for Neurochemistry (chair, Kazunori Nakajima). Therefore, researchers and clinicians in this field could get together to present and exchange the newest findings in biological psychiatry and clinical neuroscience. We owe a lot to Kanba and Nakajima for the success of the Congress to attain more than 500 registrations to the congress

Nature power always dominates human activity. The Typhoon No. 21 (named Jebi) attacked Osaka-Kobe Area on 4 September with the maximum wind velocity over 58 meters/ second, which was the most powerful typhoon landed on Japan in recent 25 years, causing 13 dead and 912 injured. Electric power supply to more than 2.247 million houses was interrupted severely affecting the infrastructure of daily life of the people living in Kansai Area.

Kansai Airport was paralyzed by flood to the whole No. 1 runway and the No.1 terminal building. Furthermore, a tanker crashed the Kansai Airport Bridge leaving the Airport Island isolated with 3,000 passengers and 2,000 staff staying overnight. Due to the breakdown of the Kansai Airport function, many oversea congress participants were forced to bypass through other airports in Fukuoka, Takamatsu, Nagoya, Tokyo, etc. We were so thankful to the speakers and participants who sacrificed extra time and cost to overcome this inconvenience to fulfill their responsibilities. We were informed 70 preregistered participants could not actually join the congress due to this natural disaster. Another natural

disaster, Hokkaido Earthquake also happened on 6 September with Mj 6.7/ Mw 6.6, causing 41 dead, 749 injured, and 2,000 houses broken. Due to the blackout through whole Hokkaido Area, daily life of the people in this area were severely affected and some expected participants from Hokkaido could not come to the

The executive committee of the WFSBP held in Kobe discussed this matter and has informed to those who could not come due to the traffic problems are eligible to transfer the registration to the next Vancouver WFSBP Congress. The application to this option has already closed and no more request can be accepted, because the account of Kobe Congress has been officially audited and closed.

Learning Autism Management for Autistic Children: A Report of a One-day Training in Peshawar, Pakistan

One-day training organised by Horizon, a nongovernmental organization, for management of autistic children was well-attended by psychiatrists, psychologists, educationists, and parents of autistic children as target population.

The purpose of the training was to mobilise the strengths and human resource of social support workers for autistic children. In this one-day training, Afzal Javed, the president-elect of the World Psychiatric Associatio, and The President Asian Federation of Psychiatric Association started to outline the objectives of this training in his keynote speech. Then, Noor us Sahar Shabnum, a special education expert from Canada, and Ali Ahsan Mufti (the executive board member of Horizon and Ibadat Hospital in Peshawar, Pakistan did the training.

Pre-and post-training tests were administered on target population of the training and longitudinal comparisons of the test results, favouring the effective learning outcomes of diagnostic aspects addressed by Ali Ahsan Mufti, educating autistic children entitled by Ms. Noor us Sahar Shabnum a Canadian Special education expert. This activity was highlighted and given mass media coverage for public awareness. Afzal Javed insured that this activity will be further highlighted at international forums and some experts of child psychiatry will collaborate with Horizon in future trainings He stressed the need for giving proper attention to mental health issue at the school level because teachers-being in close contact with the childrn can play a big role in identifying the problems. He said that school-based mental health facilities are non-existent in Pakistan. Khalid Mufti as chosen very important topic which is very much needed.

Afzal Javed said that a study carried out in England revealed that spending a pound sterling on the school mental health could save the country 14 pounds spent on the treatment of a mentally ill person at a later stage. Our policy makers must try to understand this strategy.

Autism management training was an annexation of Horizon's 2014 activities to address child mental health problems. After Army Public School massacre in Peshawar, Pakistan, inclusively hands on training one on one and group therapies were provided to victim family. A series of child protection management trainingswas carried by Horizon in preamble of 2017 as an intervention approach to cope a raising wave of child abuse. Horizon intends to organise more activities to address mental health problems of children at local and national level. (The author denies any conflicts of interest in writing this article.)

Clinical Trial Education and Language Translation: Two Recent JYPO Activities

Japan Young Psychiatrists' Organization (JYPO) is a certified non-profit organisation aiming at improving young psychiatrists' skills and broadening their perspective around psychiatric field. In this report, we introduce two of our main activities - clinical trial education and language translation:

Clinical Trial Education (led by Moriou Aki)

The workshop on clinical trial education is an annual popular event of the JYPO. The recent workshop was held on 9 December, 2018 at Kyoto University. We invited some professors or young researchers to be

lecturers and to conduct workshops. At the workshop at Kyoto University, the lecturers were Toshi A. Furukawa (Department of Health Promotion of Human Behavior, Kyoto University), Aran Tajika (Department of psychiatry, Graduate School of Medicine, Kyoto University), and Koji Kawakami (Department of Pharmacoepidemiology, Graduate School of Medicine and Public Health, Kyoto University).

Furukawa is one of Japanese front-line researchers of evidence-based medicine (EBM) on psychiatry, and has done various meta-analysis studies and megatrials such as "Meta-analysis of New Generation Antidepressants (MANGA study)," "Comparative Efficacy and Acceptability of First- and Secondgeneration Antidepressants in the Acute Treatment of Major Depression: a Network Meta-analysis (GRISELDA study)," and "Optimising First- and Second-line Treatment Strategies for Untreated Major Depressive Disorder (SUN © D study)." He lectured about the history of EBM on psychiatry, and the prospected flow of researches which will appear in next 5-20 years.

Tajika is a researcher who was in Toshi A. Furukawa's laboratory, and he also did a multi-centre randomised clinical trial (RCT) which took place after "Adding Smartphone-based Cognitive-behavior Therapy to Pharmacotherapy for Major Depression (FLATT project)." His lecture was about the backyard of RCTs, where he has paid attention to the motivation of doctors participating in the study. We also learned its difficulty in workshop style lecture.

Kawakami is an epidemiologist who broadens the frontier of real world data research in Japan. He has shown us the evidence of observational research's strength rather than RCTs, and introduced database research using medical check-ups for school students. He is now striving for the collection of wasted data of health check-ups in schools, in an attempt to find the connection of the data to each person's life-long database.

Through this programme, we have learned the situation surrounding psychiatric EBM, and have gained a future prospect of psychiatric clinical trials. We hope that many young psychiatrists in Japan would be motivated to improve the clinical situation through clinical research.

Language Translation from English to Japanese (led by Ryo Sawagashira)

Language translation from English to Japanese is one of the core activities of the JYPO. In the past,



the JYPO contributed to translate the English version of "Positive and Negative Symptom Scale (PANSS)" into Japanese language and the proposed International Classification of Diseases (ICD) 11 diagnostic guideline into Japanese. Many psychiatrists in Japan have popularly used the Japanese version of PANSS, so it is indispensable in daily practice and clinical research.

Since 2004, several young psychiatrists in Japan have translated parts of articles published in World Psychiatry into Japanese. As you know, World Psychiatry is published every four months and contains many sophisticated articles contributed from all over the world. Unfortunately, few psychiatrists read all contents of articles in this journal carefully in Japan. Therefore, articles in Japanese language are highly welcomed by Japanese psychiatrists. For one issue, about 10 young psychiatrists contribute to translation from English to Japanese. We actively discuss the contents of articles and brush up them repeatedly. Before finalising our manuscripts, Tsuyoshi Akiyama (the director of department of neuropsychiatry, the Nippon Telegraph and Telephone (NTT) Medical Center in Tokyo, and a member of the international committee of the Japanese Society of Psychiatry and Neurology), kindly supervises them. Thanks to him, we young psychiatrists can have these precious opportunities to improve our language translation skills and psychiatric knowledge through translation activities. Finalised translated manuscripts are accessable on the JSPN website three times a year. We believe that language translation of World Psychiatry has two benefits:

- to broaden the latest scientific findings to psychiatrists in all over Japan. This can contribute to improving the level of skills and knowledge of psychiatrists in Japan.
- to give opportunities for early career psychiatrists to gather various skills and knowledge in language translation itself, which is a fascinating activity for young motivated psychiatrists. Therefore, we strongly think language translation activity is indispensable for the JYPO. (All authors declare no conflicts of interest in writing this report.)

Mental Health Issues of Asylum Seekers, Refugees, and Emergency Service Personnel

In recent months, I have been honoured to represent the Royal Australian and New Zealand College of Psychiatrists (RANZCP) at various conferences in Asia. In October 2018, I was one of the keynote speakers at the International Congress of the Pacific Rim College of Psychiatrists in Myanmar and presented about "Pathways and Progress in Addressing Physician Mental Health and Wellness." In November, I was honoured to present the keynote lecture at the 46th Thai Annual Congress of Psychiatry on "Professionalism, Ethics and Self-care for Psychiatrists," and in mid-December, I was one of the keynote speakers at the 2018 Hong Kong College of Psychiatrists International Mental Health Congress delivering a lecture "Looking after the Mental Health of Vulnerable Minority Groups." I was pleased to be able to strengthen friendships with colleagues from a number of Asian and Pacific organisations.

The RANZCP has continued to be active in its work on addressing asylum seeker and refugee mental health. We have updated our position statement on the mental health needs of child asylum seekers and refugees which strongly advocates our opposition to the detention of child asylum seekers. We have also produced a webinar on medico-legal assessment and report writing for asylum seekers and refugees which provides practical guidance on how to deal with some of the challenges of working with asylum seekers and refugees including obtaining medical records, constructing medico-legal documents and balancing clinical objectivity whilst responding to high levels of distress and trauma.

As part of the work and partnerships that the RANZCP has developed to help improve mental health outcomes for current and former serving members of the Australian and New Zealand defence forces and veterans, the RANZCP has begun to extend this work to the mental health of police and emergency services personnel. We have met with a number of police and emergency services commissioners to invite them to work with the RANZCP to address the individual and collective mental health of their personnel.

Finally, we are looking forward to strengthening our relationship with the AFPA by hosting the 7th World Congress of Asian Psychiatry, 21 - 24 February, 2019 in Sydney, Australia. The World Congress of Psychiatry will support AFPA's mission to promote mental health in the Asian region. More information at www.afpa2019. com.
